

RULES

1. This competition ("the Competition") is conducted by Panarottis Advertising (Pty) Ltd ("Panarottis") and 5FM (a South African Broadcasting Corporation ("SABC") radio station) and may only be entered into by persons who are resident in South Africa and who are 18 years or older. No persons who are directors, members, partners, employees franchisees, or agents of, or consultants to, Panarottis, 5FM or the SABC, their marketing service provider(s) utilised in connection with this Competition, any supplier of goods or services in connection with this Competition, any other person who directly or indirectly controls, or is controlled by, them, or any spouse, life partner, parent, child, brother, sister, business partner or associate of any of such persons, may enter into the Competition.
2. A copy of these Competition rules ("the Rules") is available on www.panarottis.co.za. These Rules may be amended by reasonable notification via the Panarottis website at any time during the Competition, and will be applied and interpreted by Panarottis and its decision regarding any disputes relating to such meaning and/or content will be final and binding.
3. Participation by the entrants in the Competition constitutes an agreement to abide by these Rules.
4. The Competition starts on 1 November 2011 and ends on 31 January 2012 with a winner being selected for each month of the competition.
